SUBJECT: Planned System Maintenance - Update

The 30" MLV Replacement project originally scheduled for July 27, 2026 through August 14, 2026 has been deferred to 2027. Please refer to the 3rd revision of the 2026 DTE Gas Maintenance by Month document for the most up-to-date maintenance dates.

Please note, DTE Gas Operations are expected to remain constrained due to planned Compressor Maintenance effective Gas Day 07/13 - Timely Cycle until Gas Day 08/21 – Intraday 3 Cycle. The work is expected to impact Storage Injections and EUT nominations.
