Secondary Pricing Options

Mostly Commercial or Small Business Customers

D3 General Service

Standard service for our business customers desiring service at secondary voltage and having an approximate 350 hours use load profile or less

D4 Large General Service

Helps commercial customers with longer hours of operation (> 350 hours use) save money on energy (Large stores, Fast Food, etc.)

D3.1 Unmetered General

Applies to customers whose load that can be readily calculated and are impractical to meter, such as billboards, railroad crossings, or cable TV power supply

D3.3 Interruptible General

Save money on your general service rate by allowing DTE to periodically cycle on and off a portion of your energy use. Service to interruptible load shall be taken through separately metered circuits and permanently wired

D1.8 Dynamic Peak Pricing

Lower your business's overall energy bill by matching your energy use to price changes throughout the day. Available to secondary commercial customers. Learn more about Dynamic Peak Pricing at dteenergy.com/dppfag

D1.1 Interruptible Space Conditioning

Saves your business money on the cooling portion of your bill by allowing DTE to briefly cycle your air conditioning on and off when demand for electricity is high

D1.7 Geothermal Time-of-Day

Saves your business money when your approved equipment operates during off-peak hours; weekdays before 11 a.m. and after 7 p.m.; and all weekend long

D1.9 Experimental Electric Vehicle Rate

Provides a separately metered time of day pricing option to charge vehicles at your facility

D5 Water Heating

Save your business money by allowing DTE to briefly cycle the heating elements of your water heater

D9 Outdoor Lighting

Get dusk-to-dawn, protective security lighting using existing DTE Electric utility poles

Primary Pricing Options

Mostly Industrial Customers

D11 Primary Supply

Standard service for customers desiring service at primary, sub-transmission or transmission voltage

D8 Interruptible Primary

Available to customers that contract for a specified quantity of demonstrated interruptible load of not less than 50 kilowatts at a single location

Electric Choice

EC2 Retail Access

Applicable to customers desiring to participate in the DTE Electric Choice Program (subject to program limits)

Governmental

E1 Streetlighting

Available to municipalities desiring nighttime streetlighting service

E1.1 Energy Only

Available to municipalities for metered nighttime service for primary or secondary voltage streetlighting service

E2 Traffic Lights

Available to municipalities for traffic and signal lights

Schools

D6.2 Primary Educational Institution Rate

Available to Educational Institution (school, college, university) customer locations desiring service at primary, sub-transmission and transmission voltage

D3.2 Secondary Educational Institution Rate

Available to Educational Institution (school, college, university) customer locations desiring service at secondary voltage

D10 All-Electric School Building Service Rate

Available to customers desiring service in school buildings served at primary voltage, provided the space heating and water heating for all or a substantial portion of the premises is supplied by electric service and is installed on a permanent basis

Riders

Special supplemental rates associated with other pricing options

R1.1 Metal Melting

Optional interruptible service for customers with all electric metal melting operations. Available to both secondary and primary (commercial and industrial) customers

R1.2 Electric Process Heating

Optional interruptible service for customers that use electric heat as an integral part of their processes. Available to both secondary and primary (commercial and industrial) customers

R2 Special Purpose Facilities

Charges to customers who require special facilities to accommodate extraordinary requirements in which DTE is required to install for the specific use of the customer. Available to both secondary and primary (commercial and industrial) customers

Riders (con't)

R3 Standby

Required service for customers operating on-site generation to serve some, or all, of their load requirements. Standby service provided under this tariff serves the power supply requirements of load that is normally served by the customer's generator. Emergency generators are exempt from standby service and standby service is optional for customers operating generators or prime movers solely for use to provide load for testing equipment such as regenerative dynamometers. Available to both secondary and primary (commercial and industrial) customers

R4 Resale of Service

Under certain conditions, owner or operators of multiple occupancy buildings may purchase energy that may be resold. Available to both secondary and primary (commercial and industrial) customers

R5 Cogeneration

Customers who employ cogeneration technology (steam, exhaust steam or waste steam used for the generation of electricity) as an energy source and sell electric output to DTE. Available to both secondary and primary (commercial and industrial) customers

R6 Small Power Producing Facilities

Customers who develop small power producing facilities and sell electric output from their facility to the Company. Available to both secondary and primary (commercial and industrial) customers

R7 Greenhouse Lighting

Provides energy savings for customers desiring high intensity discharge lighting service (separately metered) for greenhouses or other environmentally controlled growing facilities. Available to secondary (commercial and industrial) customers only

R8 Space Conditioning

Provides energy savings for separately metered electric space conditioning. Available to secondary (commercial and industrial) customers only

R10 Interruptible Supply

Available to Rate D11 customers to have some of their connected load served on interruptible service

R12 Capacity Release

Customers who desire a payment for reducing loads during agreed upon times of not less than 250 kW at a single location. Available to both secondary and primary (commercial and industrial) customers

R13 Dispersed Generation

Customers who have on-site generators desiring a payment for operating their generation at the request of DTE. Available to both secondary and primary (commercial and industrial) customers

R16 Net Metering

Customers operating on-site generation which satisfies the Renewable Resource eligibility requirements. Available to both secondary and primary (commercial and industrial) customers

R17 Voluntary Renewable Energy (MIGreenPower™)

Customers who desire to have a greater portion of their electric use attributed to renewable resources. Available to both secondary and primary (commercial and industrial) customers

Rider DG Distributed Generation

Customers with on-site distributed generation desiring to operate in parallel with the Company's system and take service for their supplemental needs. The generation capacity shall be no greater than 100 kW at a single location. Available to secondary (commercial and industrial) customers only
